

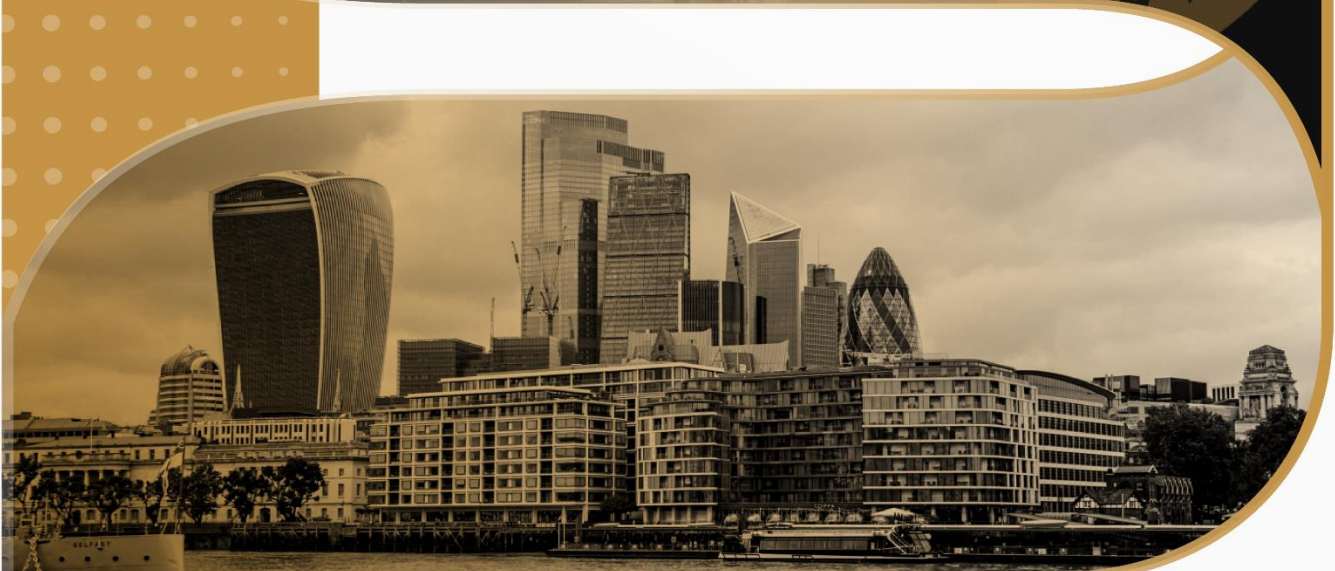

EQUAL OPPORTUNITIES POLICY

Our workers and applicants for employment shall not be disadvantaged by any policies or conditions of service which cannot be justified as necessary for operational purposes.
